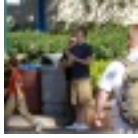

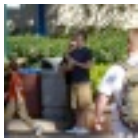
Trent:

As far as the trial, I do not know much. I have not been communicated with since the arrest. Let me say this, and it is nothing different then what I told Brad, so I think I can say it.

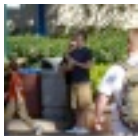

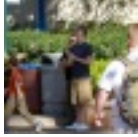
As I stated, I am cooperating with the police. I have no reason not to. All I can say is that yes, something did happen. I'm not sure what you are meaning by damages that I have done.

I said Yes, something did happen. If it seems that way it's because I am limited on what I can actually say.



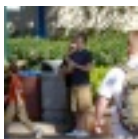

I never said I wasn't doing anything official at this point. What I said was I have never officially wrote or filed charges on Tommy.



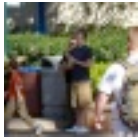

What more do you want me to say? I am being completely honest with you.What part would you like me to explain better and I will try my best.



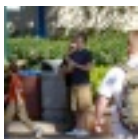

Trenton- I can't discuss that. I really cannot. I am not trying to talk lawyer, but I cannot discuss that at all.



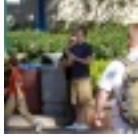

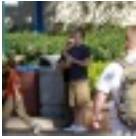
All I see is fear – fear that the case will be hampered by you speaking the truth instead of speaking exactly what they tell you to speak. That's sad.
